Dear Parent/Carer

I am writing to seek your views on a proposal to alter the timing and format of the school day at Newark Academy from September 2017.

In summary, the proposal is to begin the school day 20 minutes earlier than the current start time. We also propose to introduce a split lunchtime to ensure that all students have adequate time and space to enjoy their lunch break, particularly as our student population continues to rapidly expand.

This will mean that the school day will then finish at 2.55pm to enable the Academy to provide a range of comprehensive clubs, activities and additional study periods which extend the school day until 4.00pm. By extending the school day we are able to provide all students with a range of opportunities to participate in a range of clubs and activities that help develop the whole child as well as undertake important additional study where necessary.

There are a number of reasons why we believe that a change in our school day is necessary and have highlighted 3 key considerations below:

Student safety. Many students attend Newark Academy from out of catchment area and require public transportation to get to and from school. Due to the recent changes in public transport timetables, many students are now left to wait for a significant length of time at the end of the school day to return home. Often our students leave school in the dark during the winter months, particularly following after school activities and the weather can often be inclement. To ensure that all our students are supported to return home safely and promptly our proposal therefore will be to end the school day at 2.55pm unless students take advantage of the clubs and activities that will be offered as part of our extensive enrichment programme. This will mean that the school day will end at 4.00pm for those students wishing to take advantage of our enrichment programme.

Student Progress and Attainment: We believe that the school day for students starts too late and finishes too late, particularly as our students begin to arrive from 8.00am with the vast majority onsite before 8.30am. Experience tells us that the 'prime learning' time for students is earlier in the day. To maximise 'prime learning time', we propose to start our school day earlier and reorganise our formal morning registration period which currently sits at the start of the school day. Students will make their way directly to Lesson 1, thus minimising movement around the school and enabling students to begin studies as soon as they arrive.

Lunch time footfall and effective supervision. We are delighted that our student numbers for September 2017 are our best yet which represents significant growth in the confidence that the community has in our Academy to deliver the best education possible for our young people. As the school roll rises, this in turn places considerable strain on supervision and footfall at lunch times. Part of our solution to ensure we maintain a smooth and orderly lunch time for students is to increase the number of staff supervising the site through this period, and we are seeking to do this. Indeed, our use of teaching staff to undertake lunchtime duties is one of the reasons for such a calm and settled lunch period. Our proposal to separate and split our lunch times for KS3 and KS4 students ensures that this remains manageable and enables students to purchase and consume their lunch in a timely manner.

If these proposals are accepted by all stakeholders, the school day will operate as follows:
